

# ActivFire Advisory Note AN-016 Use of the ActivFire® Name and Image Set

This advisory note provides important information regarding the use of the CSIRO Verification Services ActivFire® Scheme Name and Image Set.

## Background

The CSIRO grants Registrants of its ActivFire® Scheme a licence to use the ActivFire® trade mark under and subject to the terms of its agreement with that Registrant. These terms apply to use of the ActivFire® Name and Image Set, in addition to the Terms and Conditions available at <a href="https://vs.csiro.au/activfire/csiro-verification-services-activfire-scheme-image-set/">https://vs.csiro.au/activfire/csiro-verification-services-activfire-scheme-image-set/</a>.

From time to time, the CSIRO may notify Registrants of requirements and limitations relating to use of the ActivFire® Name and Image Set, and Registrants must comply with these requirements and limitations.

With the increased use of the ActivFire® Scheme Name and Image Set over the years, we have prepared this advisory note to provide guidance on and notify Registrants of certain requirements and limitations on the proper use of the ActivFire® Scheme Name and Image Set.

This advisory note is provided as general information and guidance for accessing and using of the ActivFire® Scheme's name and image set but is subordinate to the formal conditions of the ActivFire® Verification Services Terms of Service (**Terms of Service**) and Certification Trade Mark Licence (**CTM Licence**).

## Use of the ActivFire® Scheme Name and Image Set

Use of the ActivFire® Scheme Name and Image Set by a Registrant is subject to the terms and conditions of that Registrant's Terms of Service and CTM Licence. This includes, without limitation, all use of the ActivFire® Scheme Name and Image Set in any manner that represents or implies that a product, equipment or system is listed by the ActivFire® Scheme.

Registrants are reminded of the following requirements and limitations on their use of the ActivFire® Scheme Name and Image Set:

- The product, equipment or system must be a validated and registered product certification, that is currently active and identified in the ActivFire® Register of Fire Protection Equipment.
- The Registrant and its registered agents/distributors of the product, equipment or system must comply with the Rules governing the ActivFire® Scheme.
- Any modifications, variations or additions to the ActivFire® Scheme Name and Image Set are subject to the CSIRO's prior written approval.
- Requests for modifications, variations or additions to the ActivFire® Scheme Name and Image Set must be submitted
  to the CSIRO in writing. The CSIRO may notify the Registrant of any fees or conditions applying to a request. The
  CSIRO may approve or deny a request at its discretion. If the CSIRO approves a request, it may impose conditions on
  use of the approved modifications, variations or additions to the ActivFire® Scheme Name and Image Set.

- All publication and production of electronic or printed documentation, packaging and labelling which references an
  ActivFire® product certification or bears images from the ActivFire® Scheme Name and Image Set must cease or be
  modified immediately upon the written request from the CSIRO or the CSIRO's deregistration or suspension of the
  relevant product, equipment or system.
- By using part or all of the ActivFire® Scheme Name and Image Set, you accept and are responsible for complying with
  the terms and conditions of the Terms of Service and CTM Licence, and the requirements and limitations of this
  advisory note.
