¹ All prices are in Australian dollars (AUD\$). The Goods & Services Tax (GST) is applicable to Australian companies ONLY. All fees are subject to periodic review. Any changes to fees will be notified to key APAS contacts via email and published to the APAS website [Australian Paint Approval Scheme \(csiro.au\)](http://AustralianPaintApprovalScheme(csiro.au)).

² For products where several tint bases &/or factory-mixed colours are submitted simultaneously under the one product brand or the one product line, these fees shall apply once only to the product brand or the product line submitted. Where tint bases &/or factory-mixed colours under the one product brand or the one product line are submitted separately, these fees shall be charged per application.

³ Fee applies to each certificate issued or existing certificate re-issued.

⁴ For organisations based outside of Australia and New Zealand, in addition to the audit fee, the organisation shall also cover costs for air fares, visa, travel time, accommodation and meals for the duration of the audit visit.

⁵ Annual subscriptions are based on the Australian financial year, 1 July to 30 June.

⁶ Minimum charge is \$100 + GST.

⁷ In VIC: for organisations > 100km from APAS office; other states: > 100km from capital city CBD.

⁸ Cancellation charges:

- 0-7 days, 100% audit fee
- 8-14 days 50% audit fee
- 15 days or greater – no fee

⁹ Where Clients require Purchase Order Numbers to be incorporated on invoices for APAS services rendered, they need to be supplied at the time of service engagement to avoid delay in service.
